


#### IN FOCUS: WEST STAR AVIATION EXPANSION



- New 40,000 sq. ft. hangar
- Additional 35,000 sq. ft. of shop and office space including a larger interior shop, a complete composite shop and tool room
- Scheduled for completion in late 2023 or 2024
- 110 new jobs
- \$16 Million project, state and local incentives of \$1.7 M by Colorado Economic Development Commission (EDC)
  - \$1.45 M in Colorado job growth incentive tax credits
  - Remainder paid out in cash incentives via CO's Strategic Fund




### IN FOCUS: NORTH AVENUE IMPROVEMENTS

- · Full reconstruction from 1st Street through 30 Road


- SCHEDULE Start of construction: Mid to Late May 2022
